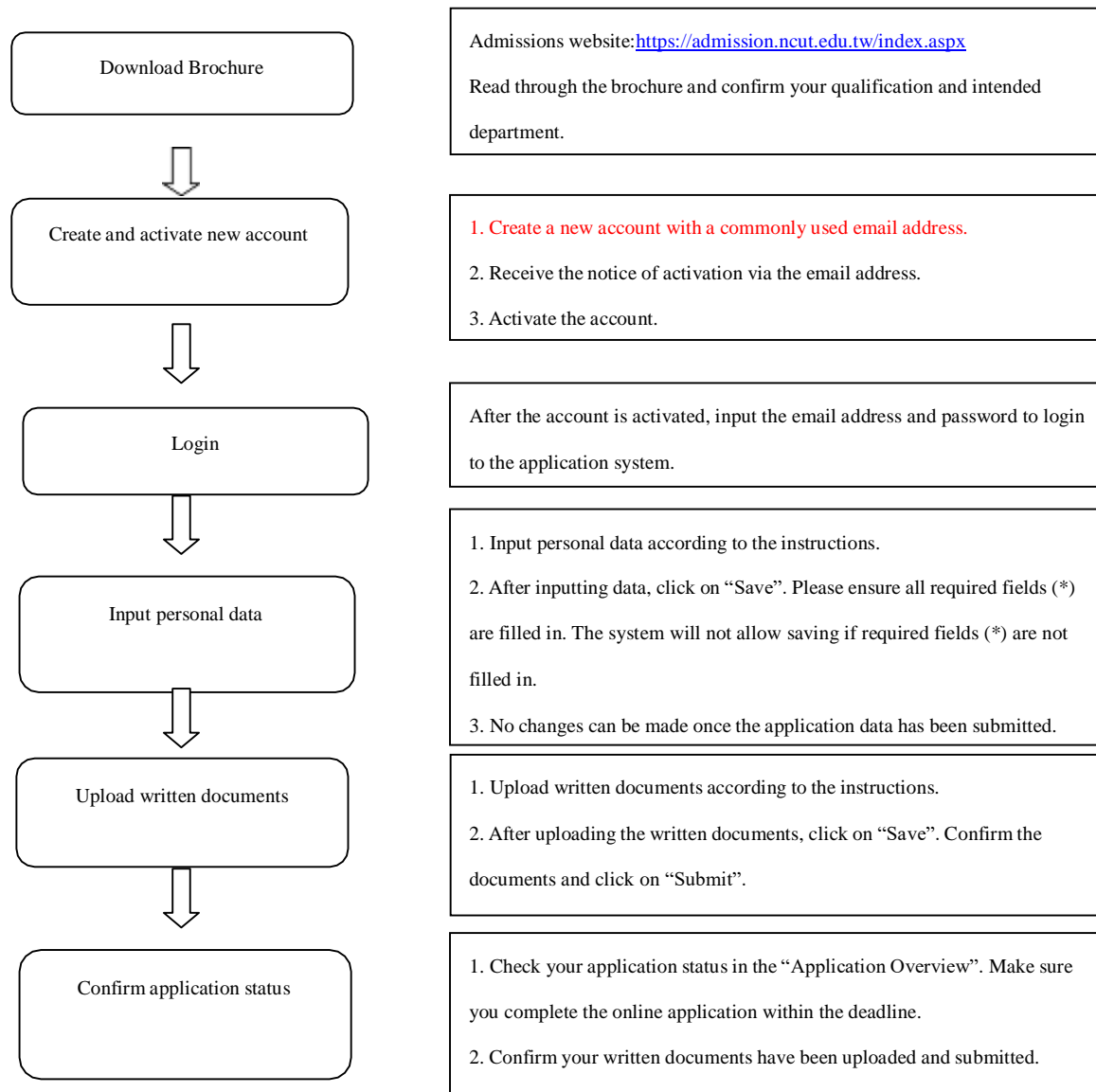

I. Study Period

Master program: one to four academic years; Doctorate program: two to seven academic years.

II. Eligibility

Applicants must accord with the regulations of “International Students Undertaking Studies in Taiwan”:

1. A person of foreign nationality who has never held Republic of China (“R.O.C”) nationality and who meets the following requirements is permitted to apply for admission to an educational institution, in accordance with the provisions of these Regulations:
 - (1) The person has never undertaken studies in Taiwan as an overseas Chinese student.
 - (2) The person has not been given a placement in the current academic year by the University Entrance Committee for Overseas Chinese Students in accordance with the Regulations Regarding Study and Counseling Assistance for Overseas Chinese Students in Taiwan.
2. A person of foreign nationality who meets the following requirements and who in the immediate past has resided overseas continuously for at least six years (up to August 1, 2025) is also permitted to apply for admission to an educational institution, in accordance with these Regulations.
 - (1) A person who at the time of their application also holds dual R.O.C. nationality shall have never had household registration in Taiwan.
 - (2) A person who before the time of their application also held dual R.O.C. nationality but no longer does at the time of their application shall have renounced their R.O.C. nationality with the approval of the Ministry of the Interior on a date at least eight full years (up to August 1, 2025) before making their application.
 - (3) A person referred to in either of the preceding two subparagraphs shall meet the requirements stipulated in Subparagraph 1 and Subparagraph 2 of the previous paragraph.

A foreign national who was selected by a foreign government, organization, or school to study in Taiwan in accordance with the Education Cooperation Framework Agreement, and who has never had household registration in Taiwan may be given exemption for the restrictions set out in the preceding two paragraphs if the competent education administrative authority gives approval.

3. An applicant of foreign nationality, who is eligible for permanent residence in Hong Kong or Macau, who has never had household registration in Taiwan, and who at the time of their application has resided in Hong Kong, Macao, or elsewhere overseas continuously for at least six years (up to August 1, 2025) may apply for admission in accordance with the provisions of these Regulations.
4. A person who was formerly from the Mainland Area and who has foreign nationality and has never had household registration in Taiwan, and who at the time of their application has resided overseas continuously for at least six years (up to August 1, 2025) may apply for admission to an educational institution, in accordance with provisions of these Regulations.

The term "Overseas" mentioned above refers to countries or regions other than Mainland Area, Hong Kong, and Macau; the term “reside overseas continuously” means that an international student has stayed in Taiwan for no more than a total of 120 days in each calendar year. When calculating the number of consecutive years spent overseas, if the initial or final year of the period is not a complete calendar year,

any time spent in Taiwan in the initial or final year must not exceed 120 days. However, time that a person has spent in Taiwan is not subject to this restriction and it is not counted when calculating how long they were in Taiwan in a particular year if the person has documentary proof that they:

- (1) attended an overseas youth training course organized by the Overseas Compatriot Affairs Council or a technical professional training program accredited by the Ministry of Education;
 - (2) spend a total period of less than two years undertaking Chinese language classes at a Chinese language center at a university or tertiary college which has Ministry of Education approval to recruit students overseas;
 - (3) spent a total period of less than two years in Taiwan as an exchange student; or
 - (4) spent a total period of less than two years undertaking an internship that they came to Taiwan to undertake with the approval of the designated central competent authority.
5. An international student applying to study at an educational institution in Taiwan in accordance with the provisions of the two previous articles is **limited to only applying once**. Upon completion of the course of study at a school in Taiwan, the student's admission to another school's academic level shall be handled in the same manner as the admission procedures for local students except for an application for a master's degree or higher levels of graduate studies, in which the application can be processed with the procedures of each individual school.
6. Applicants who have graduated from a high school, junior college or university recognized by the Ministry of Education of the R.O.C., or with academic qualifications equal to our educational system, may apply for admissions to NCUT (students with a bachelor's degree from outside Taiwan are eligible to apply for master's programs; students with a master's degree from outside Taiwan are eligible to apply for PhD programs). Students graduating from high schools overseas or in Hong Kong or Macau at the grade equivalent to the second grade of Taiwan senior high school and being admitted to the first grade of universities shall complete additional 12 credits or more in addition to the number of credits for graduation.

III. Application Method and Period (Taiwan Standard Time, overdue will NOT be accepted)

1. Application period: from 10:00AM March 10 2025 (Wednesday) to 5:00PM July 1, 2025 (Tuesday).
2. Application method: online application. Please go to NCUT "Foreign students admission application and enrollment system" (URL: <https://admission.ncut.edu.tw/index.aspx>) for registering application data and uploading written documents (refer to appendix 1).
3. NCUT does not charge any application fees to international students applying for admissions.

IV. Uploading Required Materials for Application

Please upload the following materials in PDF formats according to system instructions:

1. Copy of Passport or proof of nationality. If you are looking to apply for Financial Aid, please provide a copy of Passport.
 2. Copy of diploma of highest education level and official transcripts (those in languages other than Chinese and English should be translated into Chinese or English)
 - (1) Academic credentials from Mainland China: the regulations governing the accreditation of schools in Mainland China shall apply.
 - (2) Academic credentials from Hong Kong or Macau: academic credential verification and accreditation methods adopted in Hong Kong and Macao shall apply.
 - (3) Academic credentials from other regions:
 - i. Academic credentials earned at overseas Taiwan schools or Taiwan schools in Mainland China shall be regarded the same as those at domestic schools with equivalent levels.
 - ii. Academic credentials from areas other than the preceding two items shall be subject to the regulations of university regarding the assessment and recognition for foreign academic credentials. However, academic credentials earned from institutes or branches established in Mainland China by foreign schools shall require public notarization in Mainland China and be verified and examined by an institute established or appointed by, or through a private agency commissioned by, the Executive Yuan.
 - ✘ Note 1: For applicants submitting highest education degree or equivalent education certificate and transcripts from previously attended schools, if the university deems necessary, applicants will be required to provide further certificate documents verified by the Ministry of Foreign Affairs.
 - ✘ Note 2: Admitted student upon registration will be required to submit diploma and transcripts (certified copy) verified by Taiwan's foreign consulate or representative office.
3. **Copy of bank letter certifying sufficient fund to support studies in Taiwan: a financial statement issued by a financial institution within the past three months (the equivalent of at least NT\$100,000 or US\$3,500 annually)** or proof of full scholarship provided by a government agency, university, college, or private organization.
 - ✘ Qualification for applying student financial statement: the financial statement of the applicant should be issued by financial institutions, such as banks. Either the bank letter of a current account or a fixed account is valid. If the financial statement is provided under the applicant's name, it should be stamped and verified by the bank. If the financial statement is provided under the names of the applicant's parents, it must be accompanied by a notarized document. However, a financial statement is not necessary if the applicant is proved of full scholarship provided by a government agency, university, college, or private organization.
 - ✘ Fail to submit sufficient financial certificate before registration shall result in disqualification of admission.
4. Checklist of Required Documents for Application: applicants shall print out from the system, read, fill out and sign, then scan in PDF format to upload (appendix 2).
5. Copy of health certificate issued no earlier the most recent 6 months by hospitals.

- ✘ Health certificate can be submitted once confirmed admission and before registration. Fail in submission will result in disqualification. Those who fail the health check will be subject to the Immigration and Immigration Law, the Residence and Residence Permit for Foreigners and other relevant regulations.
6. Copy of autobiography in Chinese or English (approximately 300 to 1000 words) (refer to appendix 3).
 7. Copy of study plan written in Chinese or English (refer to appendix 4).
 - 8. Language proficiency certificate.(English proficiency test: TOEIC 550 or its equivalent, Chinese proficiency test:TOCFL level A2 or HSK level 4 or above.) If the official language of the country is English, no English proficiency certificate is required.**
 9. Credentials required by individual department/program.
 10. The declaration statement (appendix 5): applicants shall print out from the system, read, fill out and sign, then scan in PDF format to upload.
 11. The authorization letter (appendix 6): applicants shall print out from the system, read, fill out and sign, then scan in PDF format to upload.
 12. The application form for Enrollment Scholarship (appendix 7): applicants shall print out from the system, read, fill out and sign, then scan in PDF format to upload.

V. Miscellaneous

1. Individual academic programs reserve the right of determining minimum requirement standards based on their sole discretion when evaluating applicants' Chinese/English proficiency.
2. Each applicant can concurrently apply two departments at most. The applicant can only choose one program in a department if there are many programs provided in the same department. If the applicant applies two departments, please submit application document to each department separately. After the admission result is announced, the admitted applicant can only choose one department to register and enroll if there are multiple acceptance letters.
3. In the event of any cheating, plagiarism, falsification of information or documents, and dishonest presentation or submission of any University credentials, the international student shall be disqualified of admission. For registered students, the student status shall be revoked and the student shall not be issued with any relevant academic certification. For those found after graduation, the graduation and diploma shall be revoked.
4. If any foreign student applies for and is granted with household registration, registration of moving-in, naturalization and recovery of R.O.C. citizenship, he or she will lose his/her student identity, resulting in expulsion from school.
5. If any student is expelled from school because of failure in conduct or academic performance, or charged and sentenced for imprisonment in criminal cases, he or she will be disqualified for re-application. For those who violate this regulation will be disqualified for his/her admission or expelled from school.
6. Admitted applicants must submit registration agreement before the deadline declared in this admissions brochure. The applicants will be disqualified if the required documents are not submitted before due day. The vacancy will be filled by qualified students in sequence.
7. Admitted applicants must present valid proof of medical insurance plans covering at least 6 months from the date of entry into the R.O.C. The evidence must be verified and validated by R.O.C.

- consulates/representative offices prior to submission. Continuing students shall present valid R.O.C. National Health Insurance certificate, which shall be effective throughout the period of studies.
8. In the event of late enrollment delayed for less than one third of the semester, students will be permitted to register for the current semester. In the event of late enrollment delayed for over one third of the semester, students shall register for the second semester or the following academic year.
 9. In an effort to encourage international students to undertake studies in Taiwan, international students can apply for the Enrollment Scholarship and the Scholarships for International Students. All the foreign students who meet the requirements are exempted from tuition fees in the first year of school. (Apply together with admission application).  10. All received hard-copy application materials become property of NCUT and will NOT be returned to applicants in any circumstances.
 11. In accordance with the Personal Information Protection Act of the ROC (Taiwan), the applicants' information should be used and managed carefully to safeguard their personal rights. All information is used for application of enrollment to NCUT only. NCUT will uphold the responsibility of the prudent administrator to administer the applicants' personal information, which is used for application purposes only. For all applicants of NCUT are regarded as granting the consents to our school to use the applicants' personal information and academic records for the fair use in applications. NCUT will use the information to (1) notify the applicants and (2) prepare enrollment documents or students' database.
 12. Should you have any concerns regarding the results of the application, you may fill out the Admission Appeal Form for International Students (see appendix) and submit to the Admissions Committee within 30 days after the announcement of admission result, with specific reasons and supporting documents. Unnamed appeal cases will not be addressed.
 13. Should there be any discrepancy between the Chinese and English version, please refer to the Chinese as reference. Matters not set forth explicitly in the Brochure shall be dealt with in accordance with NCUT Guidelines of International Students Admissions and settled by the international student admissions committee.

- I. Scholarships are established for the purposes of facilitating international education and enrolling international students at the National Chin-Yi University of Technology (the “University”) with excellent academic standing, and encouraging them to pursue their studies.
- II. Subjects: The International Industrial Talent Education Special Program (INTENSE Program) or new international students (excluding students from the International Bachelor Program, Hong Kong, Macau, and Mainland China, as well as overseas Chinese students and exchange students) who are officially enrolled at the University and who have not received government scholarships.
- III. Mode:
 - (1) Free tuition and miscellaneous fees for the first and second year for doctoral students studying at the University; free tuition and miscellaneous fees for the first year for international students; free tuition and miscellaneous fees for the first semester for other international pre-graduate students studying at the University.
 - (2) Graduate students who have enrolled and completed registration from the second semester of the 2021 academic year (inclusive) may receive an additional NT\$5,000 scholarship per semester (up to four semesters; subject to two semesters for other international pre-graduate students).
 - (3) Starting from the 2024 academic year, master's students enrolled in the new specialist program (INTENSE Program) who have completed registration will be provided with a scholarship of NT\$5,000 per semester (up to a maximum of four semesters). Tuition and fees for the first year are subsidized by the National Development Council (NDC) (NT\$100,000 per academic year). Any shortfall will be covered by the university. For the third and fourth semesters, students must pass evaluations by both the school and enterprises. The NDC will subsidize tuition and fees for 70% of the students (NT\$50,000 per semester), and any shortfall will be covered by the University. The remaining 30% of students will receive subsidies according to the Guidelines for the Establishment of International Student Scholarships of the National Chin-Yi University of Technology.
- IV. Application process: After international students have enrolled, the Office of International Affairs will make a list with the Offices of Student Affairs and submit it to the President for approval.
- V. Those who have already been awarded a scholarship under the Guidelines are not eligible to apply for other similar scholarships at the University. Eligibility will be withdrawn if enrollment is not completed or suspended. Students may not re-apply for a scholarship if they re-enroll after suspension.
- VI. Funding sources: Scholarships are awarded from the University Student Financial Aid Fund.
- VII. An Evaluation Committee of International Student Scholarships and Financial Aid has been set up to review scholarship applications from international students, comprising five persons selected by the President from members of the University Student Financial Aid Committee, one of whom is elected as the convener of the Committee.
- VIII. The Guidelines enter into effect from the date of promulgation following ratification by the University Student Financial Aid Committee. The same process shall apply to any future amendments.

- I. This scholarship is established to encourage international graduate and undergraduate students actively learning Chinese, improving their Chinese language skills and strengthening their career competitiveness after graduation.
- II. Subjects: The International Industrial Talent Education Special Program (INTENSE Program) or international graduate and undergraduate students formally registered at the University (excluding the International Bachelor Program, students from Macau and Hong Kong, overseas Chinese, mainland Chinese and exchange students) who have not received government scholarships since the second semester of the 2021 academic year (inclusive). Two-year technical program, four-year technical program, and graduate students who have studied at the University for two semesters (inclusive) or other international student who studied at the University as pre-graduate student for one semester (inclusive) are also eligible to apply (excluding graduates or students resuming their studies after suspension or extension of studies).
- III. Number of applications: One application every semester starting from the third semester. Other international pre-graduate students may apply once only starting from the second semester.
- IV. Exam: The Language Center of the University will hold two Chinese tests every semester. International graduate and undergraduate students shall attend one test every semester and may not repeat a test. From the third semester, the test results of the previous two semesters will be used as a pre-test score (A) and the test results from the previous semester will be used as a post-test score (B). Other graduate students who are admitted as international pre-graduate students shall attend the Test of Chinese as Foreign Language, TOCFL when applying for a master's degree.
- V. Category: The scholarship is divided into full and half scholarships.
- VI. The scholarship will be distributed in the order of the same nationality, period (spring, fall class), and school system (same for students from different countries).
- VII. Scholarship review standards and methods:
 - A. Full scholarship: A scholarship covering full tuition and miscellaneous semester fees.
 1. Graduate students: Apply in the third and fourth semesters.
 - (1) Scholarship standards for the third semester: Study at least six credits in each of the previous two semesters and maintain an average test score of 75 or above in the previous semester. Additionally, the student must rank in the top 20% (inclusive) (round up decimals). This is calculated using the 30% Chinese pre-test score (A), 50% Chinese post-test score (B), and 20% Chinese progress score (B-A) from the previous two semesters. The student must also have a conduct score greater than 80 (inclusive) without a demerit (or two complaints). If more than one student has the same score, the student with the higher post-test score (B) shall be selected.
 - (2) Scholarship standards for the fourth semester: Study at least six credits in each of the previous three semesters (except for a thesis with confirmation from the advisor) and maintain an average test score of 75 or above in the previous semester. Additionally, the student must rank in the top 20% (inclusive) (round up decimals). This is calculated by some of the 30% Chinese pre-test score (A), 50% Chinese post-test score (B), and 20% Chinese progress score (B-A) from the previous two semesters. The student must also have a conduct score greater than 80 (inclusive) without a demerit (or two complaints). If more than one student has the same score, the student with the higher post-test score (B) shall be selected.
 2. Undergraduate students' applications starting from the third semester: Study at least nine credits in the previous semester and maintain an average test score of 65 or above in the previous semester. Additionally, the student must rank in the top 20% (inclusive) (round up decimals). This is calculated using the 30% Chinese pre-test score (A), 50% Chinese post-test score (B) and 20% Chinese progress score (B-A) from the previous two semesters. The student must also have a conduct score greater than 80 (inclusive) without a demerit (or two complaints). If more than one student has the same score, the student with the higher post-test score (B) shall be selected.

3. Graduate students who are admitted as international pre-graduate students: who pass the Test of Chinese as Foreign Language, TOCFL with a grade of B1 or above may submit the application from the second semester.
- B. Half scholarships: A scholarship covering half the tuition fees and miscellaneous semester fees.
1. Graduate students: Apply in the third and fourth semesters.
 - (1) Scholarship standards for the third semester: Study at least six credits in each of the previous two semesters and maintain an average test score of 75 or above in the previous semester. Additionally, the student must rank in the top 20% (inclusive) to 70% (round up decimals). This is calculated using the 30% Chinese pre-test score (A), 50% Chinese post-test score (B), and 20% Chinese progress score (B-A) from the previous two semesters. The student must also have a conduct score greater than 80 (inclusive) without a demerit (or two complaints). If more than one student has the same score, the student with the higher post-test score (B) shall be selected.
 - (2) Scholarship standards for the fourth semester: Study at least six credits in each of the previous three semesters in general (except for a thesis with confirmation from the advisor), maintain an average test score of 75 or above in the previous semester, and rank in the top 20% to 70% (inclusive) (round up decimals). This is calculated by the sum of 30% for the pre-test score for Chinese (A), 50% for the post-test score for Chinese (B), and 20% progress for the Chinese score (B-A) in the previous two semesters. Additionally, a conduct score greater than 80 (inclusive) without a demerit (or two complaints). If more than one student has the same score, the student with the higher post-test score (B) shall be selected.
 2. Undergraduate students' applications starting from the third semester: Study at least nine credits in the previous semester and maintain an average test score of 65 or above in the previous semester, and rank in the top 20% to 70% (inclusive) (round up decimals). This is calculated by the sum of 30% for the pre-test score for Chinese (A), 50% for the post-test score for Chinese (B), and 20% progress for the Chinese score (B-A) in the previous two semesters. Additionally, a conduct score greater than 80 (inclusive) without a demerit (or two complaints). If more than one student has the same score, the student with the higher post-test score (B) shall be selected.
 3. Graduate students who are admitted as international pre-graduate students: who pass the Test of Chinese as Foreign Language, TOCFL with a grade of A2 or above may submit the application from the second semester.

VIII. Application deadline: Announced by the Office of International Affairs.

IX. Documents to prepare:

- A. Application form
- B. Transcript
- C. Chinese test transcript from the Language Center or official transcript from the Test of Chinese as Foreign Language, TOCFL
- D. Copy of student ID
- E. Copy of passbook cover for a student in a financial institution
- F. Receipt of tuition and miscellaneous fee payment (certificate of at least half payment)
- G. Punishment and reward certificate

X. Application procedures: Graduate and undergraduate students shall submit the aforementioned documents to the Office of International Affairs before the announced deadline. The Office of International Affairs will submit the application to the International Student Scholarship Committee for review.

XI. Students who have received this scholarship may not collect a good performance scholarship, outstanding admission scholarship, and other internal and external tuition deduction scholarships.

- XII. Source of funds: Supported by a subsidy from the MOE, donations and other funds raised, and a study subsidy from the University.
- XIII. These guidelines shall be implemented upon the approval of the Student Scholarship Management Committee and principal.

- I. The Scholarships are founded to motivate international students in the National Chin-Yi University of Technology (hereinafter referred to as “NCUT”) to thoroughly pursue their studies.
- II. Subjects: International students registering at NCUT (excluding students from IBPIUC and the International Bachelor Program, Hong Kong, Macau, and Mainland Chinese, Chinese students abroad and exchange students), doctoral students who enrolled after the 2019 academic year (included), as well as graduate and undergraduate students who enrolled between the 2019 academic year and the 1st semester of the 2021 academic year. Doctoral students can complete an application upon enrollment in the first semester while students in two-year and four-year technical programs, as well as master’s students, can only complete an application after studying at NCUT for two (inclusive) semesters or more (excluding graduates and extended students).
- III. In principle, concerning the financial aid, international students in two-year technical programs and master’s students can apply for financial aid twice at most, students in four-year technical programs can apply six times at most, doctoral students can apply four times at most, and only one application can be completed in each semester.
- IV. The financial aid is organized in a full scholarship and partial scholarship
- V. Award standards and manner:
- (1) The full scholarship:
1. Doctoral students: Financial aid will be awarded after enrollment in the first semester. From the second semester, doctoral students must have a minimum average semester grade of 70 (inclusive) (not applicable to students that have no academic achievements but have begun the writing stage of the graduation thesis, as verified by the advising professor), a minimum conduct performance of 80 (inclusive), and should not have any demerit records (including three warnings) in the previous semester. Students that meet the requirements will be awarded NT\$10,000 as the full scholarship per month, for a total of six months; NT\$60,000 in total.
 2. Master’s students: Applications in the third and fourth semester, respectively
 - (1) The award standards in the third semester: At least 6 credits must be completed in each semester in the first two semesters and the average semester grade in the prior academic year ranks within the top-twenty percent (inclusive) (carrying over unconditionally after the decimal point) among international students in the same college. The same school system and the grade enrolled in the same academic year and semester must have a minimum conduct performance of 80 (inclusive) and students should not have any demerit records (including three warnings) in the previous semester. Students that meet the requirements will be exempted for the tuition and miscellaneous fees for the given semester.
 - (2) The award standards in the fourth semester: At least 6 credits must be completed in each seminar in the preceding three semesters (not applicable to students that have no academic achievements but have begun the writing stage of the graduation thesis, as verified by the advising professor) and the average grade in the prior three academic years ranks within the top-twenty percent (inclusive) (carrying over unconditionally after the decimal point) amongst international students in the same college, school system, and grade enrolled in the same academic year and semester must have a minimum conduct performance of 80 (inclusive) and should not have any demerit records (including three warnings) in the previous semester. Students that meet the requirements will be exempted from the tuition and miscellaneous fees for the given semester.
- (2) The partial scholarship:
1. Master’s students: Applications in the third and fourth semester, respectively
 - (1) The award standards in the third semester: At least 6 credits must be completed in each semester in the preceding two semesters and the average semester grade in the previous academic year must rank in the top-twenty percent to seventy percent (inclusive) (carrying over unconditionally after the decimal point) among international students in the same college, school system, and grade enrolled in the same academic year and semester must have a minimum conduct performance of 80 (inclusive) and should not have any demerit records (including three warnings) in the previous semester. Students that meet the requirements will be exempted from half of the tuition and miscellaneous fees for the given semester.

(2) The award standards in the fourth semester: At least 6 credits must be completed in each seminar in the preceding three semesters (not applicable to students that have no academic achievements but have begun the writing stage of the graduation thesis, as verified by the advising professor) and the average grade in the previous three academic years must rank in the top-twenty percent to seventy percent (inclusive) (carrying over unconditionally after the decimal point) among international students in the same college, school system, and grade enrolled in the same academic year and semester must have a minimum conduct performance of 80 (inclusive) and should not have any demerit records (including three warnings) in the previous semester. Students that meet the requirements will be exempted from half of the tuition and miscellaneous fees for the given semester.

(3) Two-year and four-year technical program scholarship:

1. Students in two-year and four-year technical programs must complete at least 9 credits in the preceding semester and must have a minimum average semester grade of 70 (inclusive) and a minimum conduct performance of 80 (inclusive). Students should not have any demerit records (including three warnings) in the previous semester. The students that meet the requirements will be exempted from half semester of the tuition and miscellaneous fees and will be awarded NT\$10,000 as financial aid.
2. Students in two-year and four-year technical program: must complete at least 9 credits in the previous semester, and must have average semester grade between 60 (inclusive) and 70 and a minimum conduct performance of 80 (inclusive), and shall not have any records of demerit (three admonitions included) in the previous semester. The students that meet the requirements will be exempted from half semester of the tuition and miscellaneous fees and will be awarded of NT\$ 8,000 as financial aid.
3. The total quota of students in two-year and four-year technical program being awarded of full scholarship and partial scholarship is limited to 20 students. For international students eligible for the aforesaid financial aid, in case of the same academic results, priority will be given to students with a higher score of conduct; in case of the same score of conduct, priority will be given to students with longer certified service hours in NCUT.

VI. Application deadline: The application for Scholarships/Financial Aid is accepted from August 10 to September 10 for the first semester and from January 15 to February 15 for the second semester.

- VIII. Application procedures: From the third semester for the master's students, the application should be reviewed by the heads of each college and submitted to the International Affairs Office for managing. Doctoral students and students in two-year and four-year technical programs should submit the information described in the previous paragraph to the International Affairs Office for managing within the time limit. The International Affairs Office will submit the documents to the International Student Financial Aid Committee for review.
- IX. Those who have already been awarded the scholarship under the guidelines are not eligible to apply for other similar scholarships in the University.
